**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 11-M in the area bounded by

The alley next north of and parallel to West Irving Park Road; a line 324.44 feet east of and parallel to North Narraganset Avenue; West Irving Park Road; and a line 261.94 feet east of and parallel to North Narraganset Avenue,

to those of a B2-3 Neighborhood Mixed-Use District.

**SECTION 3.** This ordinance shall be in force and effect from and after its passage and due publication.

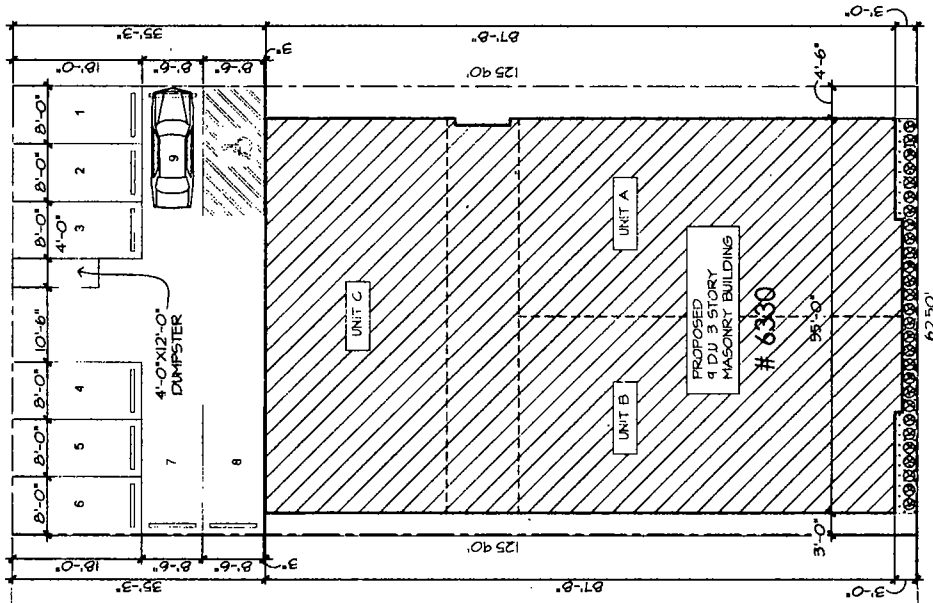

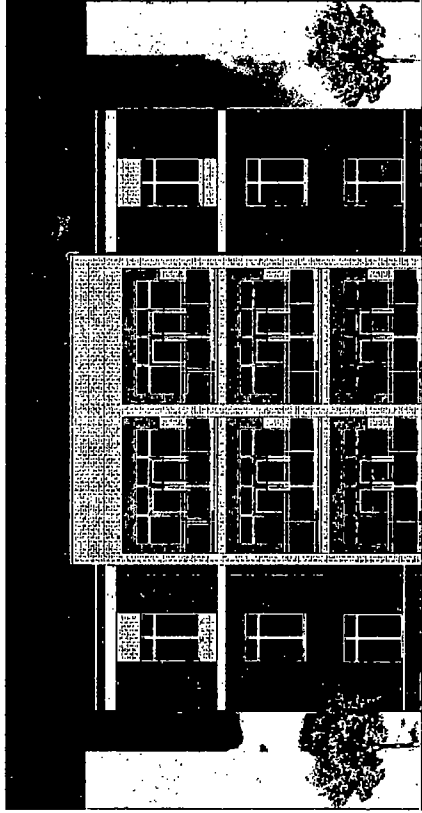

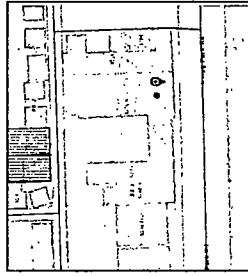

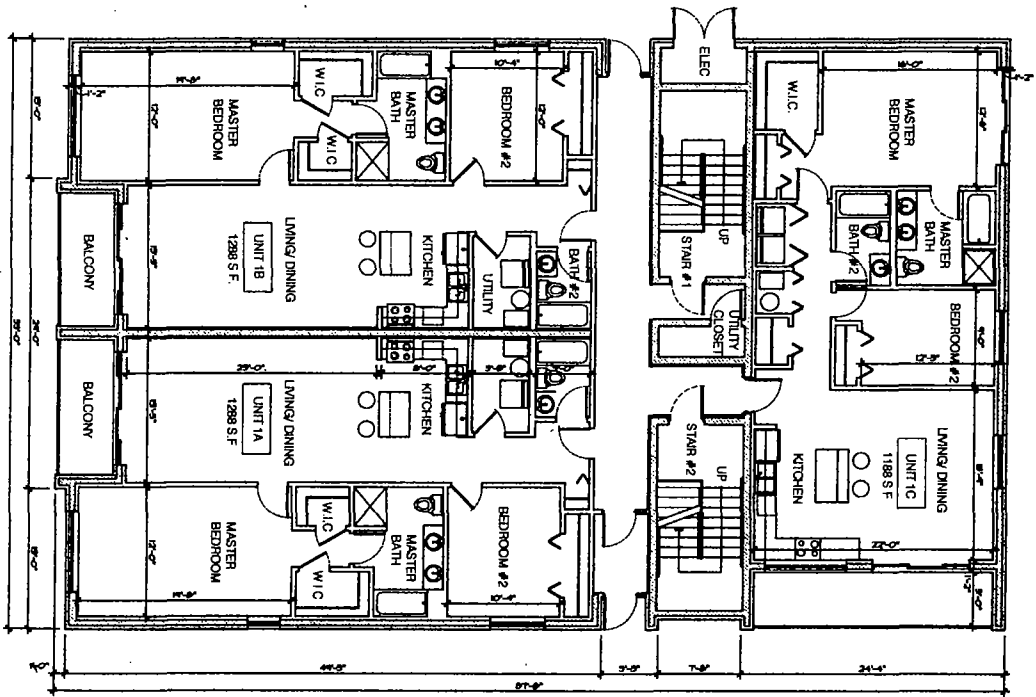

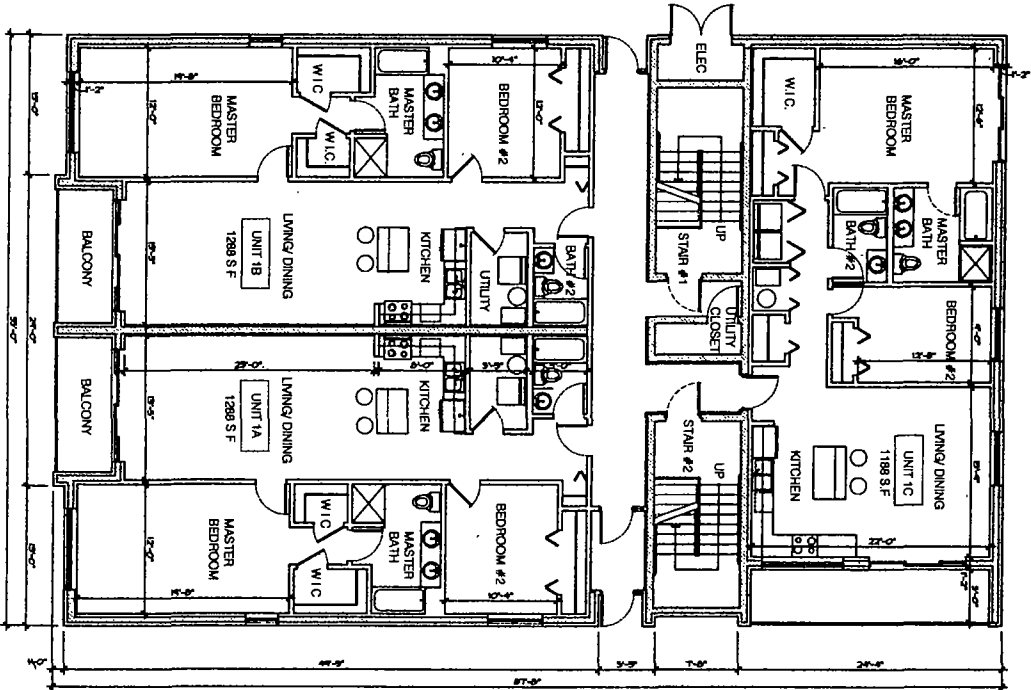

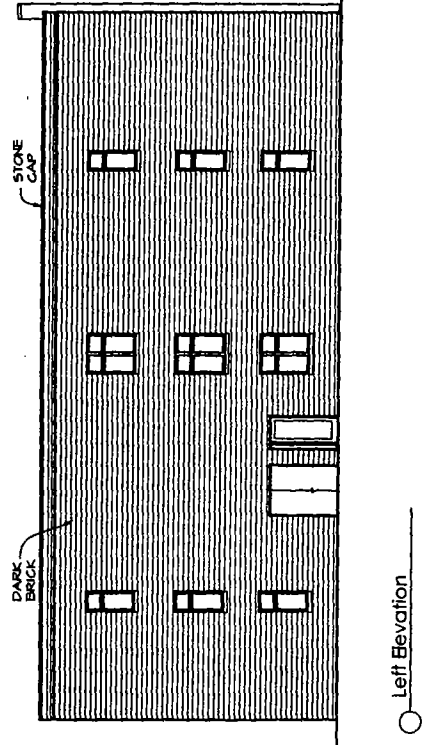

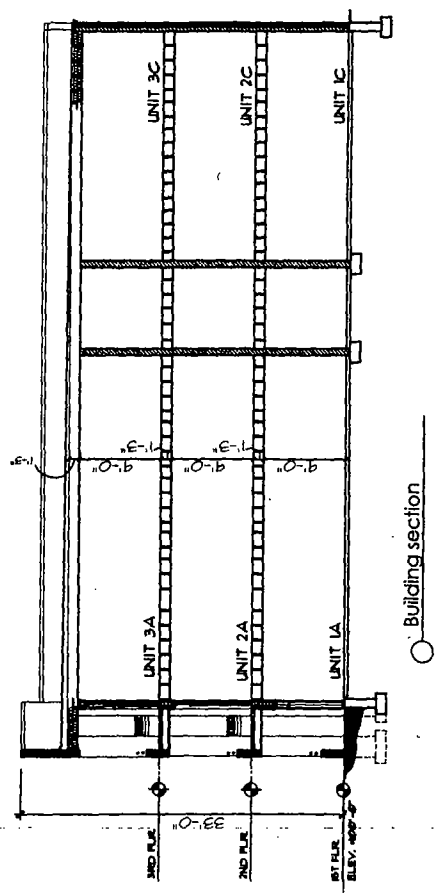
○ Rear Elevation
