ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 5-I

in the area bounded by:

The public alley next North of and parallel to West Lyndale Avenue; a line 199.68 feet East of and parallel to North Campbell Avenue; West Lyndale Avenue; a line 156 feet East of and parallel to North Campbell Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
