to those of a B2-2, Neighborhood Mixed-Use District symbols and corresponding use district is hereby established.



PROJECT DESCRIPTION

1825 Newport, LLC (the "Applicant") proposes to remodel an **existing two story** former manufacturing building located at 1819-1825 Newport into a **day care facility**. Two stories in existing building will be used solely for day care facility, with the first floor featuring class rooms and the second floor reserved for the expansion of the facility to include an open play area. All work will be done within the existing building, and existing setbacks and building height will remain unchanged. The facility will feature four interior parking spaces and four bicycle spaces.


In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 26, 2012, the undersigned will file an application for a change in zoning from M1-2 to a B2-2 Neighborhood Mixed Use District on behalf of 1825 Newport LLC for the property located at 1819-1825 W. Newport.

The applicant intends to use the existing building and renovate it for use as a day care facility. The existing zoning allows the operation of a day care facility of up to 4,500 square feet. The Applicant is proposing a facility that is greater than 4,500 square feet. The first floor, which will feature classrooms, will house approximately 9,000 square feet and the second floor, which will feature an open play area, will house approximately 11,000 square feet. If the amendment is successful, the sole use on the subject property will be a day care facility; no residential units will be part of the redevelopment of this property. *All construction will consist of interior remodeling.* Four parking spaces will also be built into the interior of the building.








F. Elevation @ Exterior: NTS
