ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The Director of Revenue is hereby authorized and directed to remove paid parking at the following location:

- W. Washburne Avenue, both sides of the street, from S. Damen Avenue to S. Wolcott Avenue
- W. 13th Street, both sides of the street, from S. Damen Avenue to S. Wolcott Avenue
- W. Hastings Street, both sides of the street, from S. Damen Avenue to S. Wolcott Avenue
- S. Clinton Avenue, west side of the street, from W. Van Buren Street to W. Tilden Avenue

SECTION 2. The Director of Revenue is hereby authorized and directed to give consideration to the installation of parking meters on:

- S. Jefferson Street, west side of the street, from W. Tilden Avenue to W. Congress Parkway
- E. Cermak Road, both sides of the street, from State Street to E. Wabash Avenue.

SECTION 3. Section 9-64-206 of the Municipal Code is hereby amended by adding the language underscored and by deleting the language struck through as follows:

9-64-205 Parking meters—hours of operation

Notwithstanding any prior ordinance establishing different hours of operation, the hours of operation for a parking meter shall be as follows:

(Omitted text is unaffected by this ordinance)

(e) Notwithstanding the days and hours of operation in subsections (a), (b), (c), and (d) of this section, parking meters shall operate:

(1) From 8 a.m. to 9 p.m., Monday through Saturday, and from 3 p.m. to 9 p.m. on Sunday at:

- 3.1 The 4500 block of S. Ashland Avenue;
- 3.2 The 0 block of E. Cullerton Street;
- 3.3 The 1900 block of S. Archer Avenue;
- 3.4 The 1800 and 1900 blocks of S. State Street;

- 3.5 The 100, 200, and 300 blocks of E. 47th Street; and
- 3.6 The 1800 and 1900 blocks of S. Wabash Avenue.

(f) Notwithstanding the days and hours of operations in subsections (a), (b), (c), (d), and (e) of this section, parking meters shall operate:


(1) From 8 a.m. to 6 p.m., Monday through Friday at:

2.1 W. Tilden Avenue, north side of the street, from S. Jefferson Street to S. Clinton Street

2.2 S. Jefferson Street, east side of the street, from W. Tilden Avenue to W. Van Buren Avenue

(f) (e) The time limits set forth above shall not replace any other more restrictive parking or standing restrictions and do not relieve a person from the duty to observe other and more restrictive provisions prohibiting or limiting the standing or parking of vehicles in specified places or at specified times.

SECTION 4 . This ordinance shall be in full force and effect from and after the date of its passage and approval.
