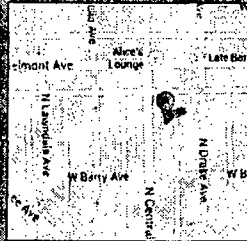
to those of a RM-4.5, Residential Multi-Unit District.
