ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the District RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No 5-1 in the area bounded by

A line 293.50 feet north of and parallel to West Charleston Street; the north-south public alley east of and parallel to North Campbell Avenue; the east-west public alley north of and parallel to West Charleston Street; a line 135.00 feet east of North Campbell Avenue; a line 243.50 feet north of West Charleston Street; North Campbell Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
