

WHEREAS, The Members of this Chamber were deeply saddened to learn of the passing on December 11, 2010, at age 49, of Brian G. Donovan; and

WHEREAS, Mr. Donovan was born at Mercy Hospital in Chicago on June 17, 1961; and

WHEREAS, Mr. Donovan grew up in the Bridgeport neighborhood of Chicago and attended Nativity of our Lord grade school before graduating from DeLaSalle High School; and

WHEREAS, Following high school, Mr. Donovan graduated from St. Joseph's College in Rensselaer, Indiana and later went on to graduate from Chicago Kent Law School; and

WHEREAS, Once out of law school, Mr. Donovan was employed at the Illinois Attorney General's Office. Afterwards, he practiced law with the esteemed Chicago law firm then known as Mayer Brown & Piatt. At the time of his passing, Mr. Donovan was employed as a manager in regulatory compliance at Commonwealth Edison; and

WHEREAS, Brian G. Donovan, who was both a successful businessman and a dedicated family man, will be missed by his relatives and friends alike and will always be remembered above all as a kind and caring individual; and
