BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Section 2-8-050 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and by adding the language underscored, as follows:

**2-8-050 Aldermanic expense allowance.**


(b) Expenditures may be made from aldermanic expense allowance funds for any of the following purposes:

(26) Hosting a paper shredding or electronics recycling event, provided that such event is open to the public. Such expense shall not be considered a gift or donation prohibited under subsection (c) of this section;

~~(26)~~(27) Payment of miscellaneous, ordinary and necessary expenses incurred in connection with the performance of an alderman's official duties.

**SECTION 2.** This ordinance shall take effect following passage and publication, and shall apply to expenditures made pursuant to section 2-8-050 beginning September 1, 2019.
