TRIBUTE TO OCTAVIA BALL

WHEREAS, The Chicago City Council has been informed of her transition by the Honorable Toni Foulkes, Alderman of the 15th Ward; and

WHEREAS, Octavia Ball was born on May 19, 1940 to Pearlie Kennedy and Henry Lee Kennedy. She confessed her faith in Christ at an early age and united with Big Jerusalem M.B.
