171 feet north of and parallel to West Irving Park Road; and North  
Marmora Avenue;

to those of an RT4 Residential Two-Flat Townhouse and Multi-Unit District is  
hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and  
due publication.


