ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District and B3-2, Community Shopping District symbols as shown on Map No. 6-J

in the area bounded by:

A line 146.01 feet North of and parallel to West 26th Street; South Christiana Avenue; West 26th Street; a public alley next West of and parallel to South Christiana Avenue.

To those of a C2-2, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.

Section 3-4. Explanation of powers granted in the statutory short form power of attorney for property. This Section defines each category of powers listed in the statutory short form power of attorney for property and the effect of granting powers to an agent.
