ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.13-G in the area bounded by

a line 77.60 feet south of and parallel to West Winnemac Avenue; the alley next east of and parallel to North Ashland Avenue; a line 114.27 feet south of and parallel to West Winnemac Avenue; and North Ashland Avenue,

to those of a RM4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

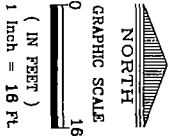
SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

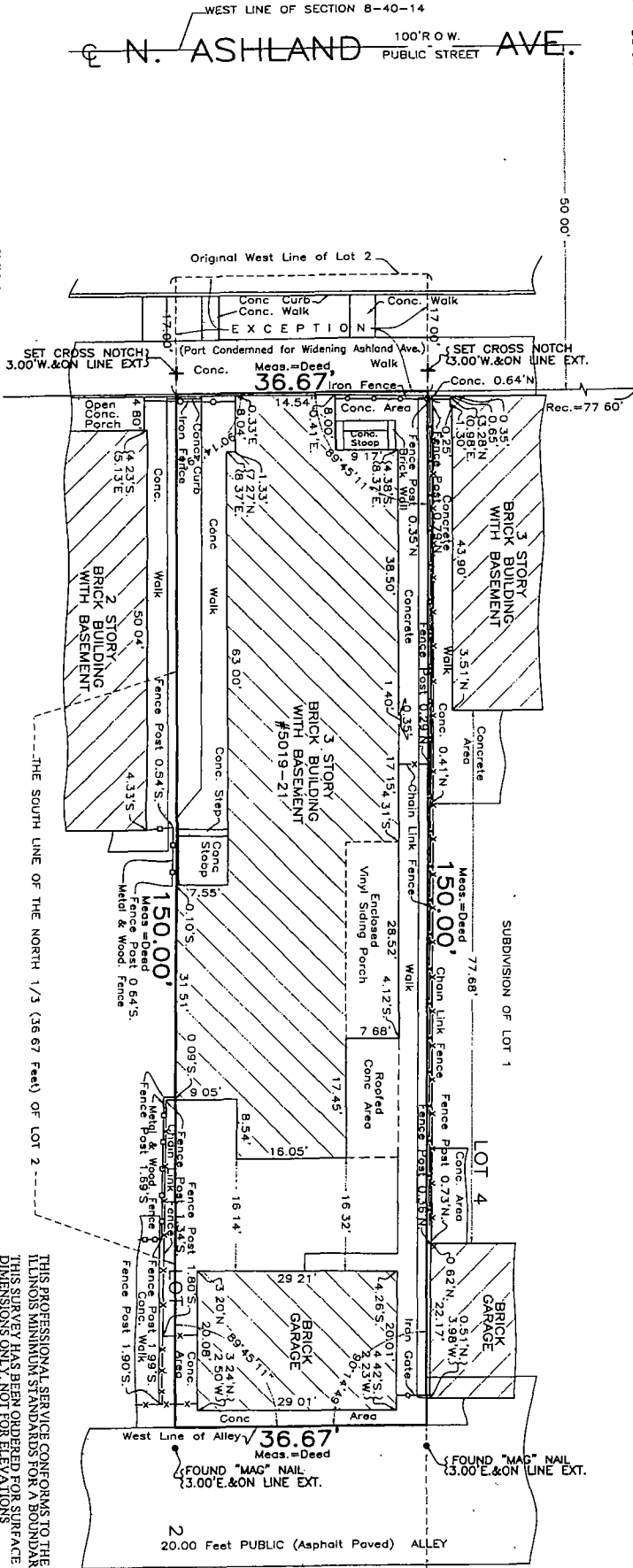
PLAT OF SURVEY
