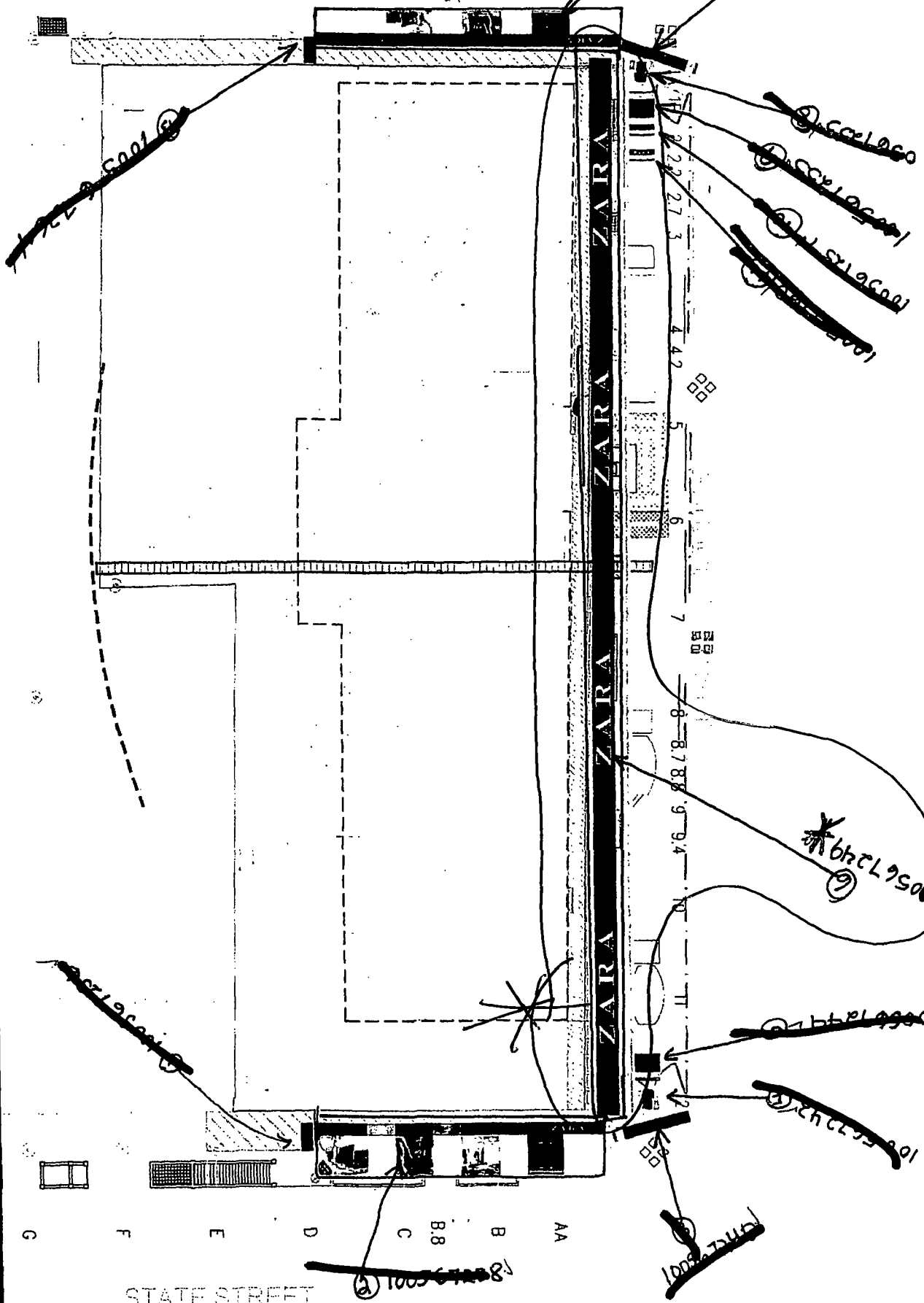

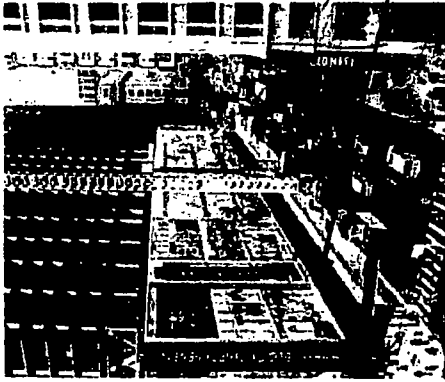
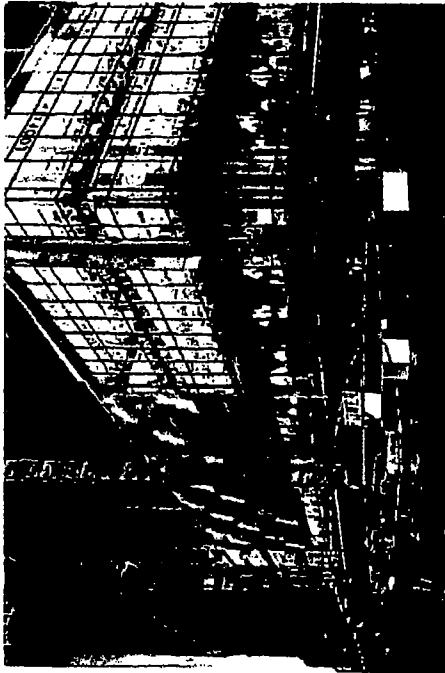
BLOCK 37 SIGNAGE - BIRD'S EYE VIEW
