ORDINANCE SPORTS CORNER Acct. No. 85280 - 5 Permit No. 1144092

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SPORTS CORNER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seventy-eight (78) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 952-56 W. Addison St..

Said Cornice(s) at N. Sheffield measure(s):

One (1) at four point six six (4.66) feet in length, and one (1) foot in width for a total of four point six six (4.66) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Two (2) at six point three three (6.33) feet in length, and one (1) foot in width for a total of twelve point six six (12.66) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at three (3) feet in length, and point one six (.16) feet in width for a total of point four eight (.48) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at four point six six (4.66) feet in length, and point one six (.16) feet in width for a total of point seven five (.75) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at four point five (4.5) feet in length, and point one six (.16) feet in width for a total of point seven two (.72) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at one point five (1.5) foot in length, and point six six (.66) feet in width for a total of point nine nine (.99) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at three point five (3.5) feet in length, and point four one (.41) feet in width for a total of four point three one (4.31) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at three point zero eight (3.08) feet in length, and point four one (.41) feet in width for a total of one point two six (1.26) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Six (6) at five point one six (5.16) feet in length, and point four one (.41) feet in width for a total of twelve point six nine (12.69) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Two (2) at four point three three (4.33) feet in length, and point four one (.41) feet in width for a total of three point five five (3.55) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at four point one six (4.16) feet in length, and point four one (.41) feet in width for a total of five point one two (5.12) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at three point three three (3.33) feet in length, and point four one (.41) feet in width for a total of one point three seven (1.37) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at nine point zero eight (9.08) feet in length, and point nine one (.91) feet in width for a total of eight point two six (8.26) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at nine point zero eight (9.08) feet in length, and point three three (.33) feet in width for a total of eight point nine nine (8.99) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at four point one six (4.16) feet in length, and point four one (.41) feet in width for a total of five point one two (5.12) square feet.

Said Cornice(s) at W. Addison measure(s):

Three (3) at five point one six (5.16) feet in length, and point four one (.41) feet in width for a total of six point three five (6.35) square feet.

Said Cornice(s) at N. Sheffield measure(s):

One (1) at eleven point seven five (11.75) feet in length, and point three three (.33) feet in width for a total of three point eight (3.88) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at eleven point seven five (11.75) feet in length, and point three three (.33) feet in width for a total of eleven point six three (11.63) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at nine point two five (9.25) feet in length, and point three three (.33) feet in width for a total of nine point one six (9.16) square feet.

Said Cornice(s) at N. Sheffield measure(s):

Three (3) at three (3) feet in length, and point three three (.33) feet in width for a total of two point nine seven (2.97) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1144092 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 07/29/2019.
