Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PARCEL G, LLC upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Canopy without Lettering or Graphics(s) projecting over the public right-of-way adjacent to its premises known as 1229 W CONCORD PL.

Said Canopy without Lettering or Graphics(s) at W. Concord PI measure(s): One (1) at seventy-seven (77) feet in length and seven point four two (7.42) feet in width for a total of five hundred seventy-one point three four (571.34) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Alfairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1617642 herein granted the sum of one hundred two (\$102.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


