ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District and the B3-2 Community Shopping District symbols as shown on Map No. 19-H in the area bounded by:

The public alley next north of and parallel to West Touhy Avenue; a line 106.40 feet east of and parallel to North Clark Street, as measured along the northern boundary line of West Touhy Avenue, and perpendicular thereto; West Touhy Avenue; North Clark Street.

To those of a B3-2 Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.


