ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C2-3 Motor Vehicle-Related District symbols and indications and all of the M2-3 Light Industry District symbols and indications as shown on Map No. 8-G in the area bounded by

A line 796.01 feet north of and parallel to West 35th Street (as measured along the west boundary line of South Racine Avenue); South Racine Avenue; West 35th Street; the east boundary line of the south fork of the south branch of the Chicago River; the northeast boundary line of the south fork of the south branch of the Chicago River; a line 497.34 feet north of and parallel to the north boundary line of West 35th Street (as measured along the west boundary line of South Racine Avenue); a line 176.79 feet east of the northeast boundary line of the south fork of the south branch of the Chicago River; a line 515.49 feet north of and parallel to the north boundary line of West 35th Street; and a northwesterly line from a point 173.77 feet east of the northeast boundary line of the south fork of the south branch of the Chicago River to along the previously stated line to a point 360.77 feet west of South Racine Avenue and parallel to West 35th Street.

NOTE: The right of way of the Chicago River is not included.







In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about January 26,2022, I, the undersigned, will file an application for a change in zoning from a C-2-3 Motor Vehicle-Related District and M2-3 Light Industry District, to a C2-3 Motor Vehicle-Related District on behalf of South Branch LLC, owner of the property located at 1200 W. 35th Street.

The applicant seeks a zoning amendment to a C2-3 Motor Vehicle-Related Commercial District to allow a reclassification of a 32-foot-wide railroad easement zoned M2-3. Except for the 32-foot-wide easement, the property was rezoned to a C2-3 on July 28, 2011 pursuant to City Council ordinance. The applicant seeks to re-zone the 32-foot-wide easement from M2-3 to C2-3 and consolidate it into a single parcel with the balance of the property which is currently zoned C2-3.

The applicant intends to use the subject property to consolidate the parcels in order to approve parking (eliminating what would be considered off-site parking due to two different zoning classifications) to allow the issuance of a Public Place of Amusement license. No change will be made to the other existing uses in the 5-story building: the first floor has commercial space for several businesses, and the upper floors 2-5 have predominantly storage spaces and 108 artists' workspace units. Currently there are 402 parking spaces.

The applicant/property owner is. South Branch LLC, 333 N. Michigan Avenue, ste 1700 Chicago, Illinois 60601. Paul Levy and Anthony Augustine are its managers.
