

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 20-F in the area bounded by

West 79th Street; a line 130.20 feet east of the east line of South Halsted Street; the public alley next south of and parallel to West 79th Street; and South Halsted Street;

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.


A. The applicant proposes to rezone the subject property from B1-1 Neighborhood Shopping District to B3-3 Community Shopping District. The subject property is currently unimproved. The purpose of the amendment to permit the development of a 30-unit, 5-story mixed-use building. The subject property is a Transit Serviced Location based on proximity to the 79th Street and the number 79 Bus Line. The applicant is seeking the following relief: (i) parking relief for a Transit-Served Locations in accordance with 17-10-0102-B, (ii) FAR increase for Transit-Served Locations in accordance with 17-3-403-B and (iii) Variation for rear yard.









(1) NORTH BUILDING ELEVATION (1) 1/16" = 1:0"




(1) WEST BUILDING ELEVATION 1/16" = 1:0"
