

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Residential Planned Development Number 1010 (PD #1010) District symbols as shown on the Map No. 14-N in the area bounded by:

West 62nd Place; a line 288.35 feet west of and parallel to South Sayre Avenue;

West 63rd Street; and South Gullikson Road

to those of a C2-2 Motor Vehicle- Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 23, 2022, the undersigned will file an application for a change in zoning from PD #1010 to C2-2 on behalf of the Applicant 560 S Vermont LLC for the property located at 7050 W 63rd Street, Chicago, IL 60638.

The Applicant intends to use the subject property as follows. The Applicant will lease the 5,500 square foot building to one or two retail or restaurant tenants.

An entity affiliated with the Applicant, Richards Building Supply, will occupy the northern, outdoor portion of the property (behind the building from W 63rd Street) to expand storage from the separate and adjacent property (7000 W. 63rd St.). The roofing off-site accessory storage will consist of neatly stacked pallets of shingle bundles inside the North part of the Subject Property. As to the delivery trucks, Richards Building Supply will place some of their trucks on the parking lot located in the Subject Property. The delivery trucks will be placed in the area that is obscured from the public. The Applicant will seek a Special Use Permission at the Zoning Board to allow accessory off-site storage of parked trucks and material.

The proposed landscaping and screening plan for this part of the Subject Property will be to use the existing landscaping and fencing consistent with the adjacent property (7000 W. 63rd St.) unless instructed to do so otherwise.

The Applicant and owner are located at 12070 W 159th Street, Homer Glen, IL 60491. The contact person for this application is Noah Hamant, 33 N LaSalle Street Suite 2800, Chicago, IL 60602 and can be reached at (312) 580 1593.


