A line 401.80 feet north of and parallel to West Adams Street; South Waller Avenue; a line 351.80 feet north of and parallel to West Adams Street; and the alley next west of and parallel to South Waller Avenue.

To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.


