BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Community Shopping District symbols and

indications as shown on Map No. 9-G in an area bound by:

North Dayton Street; a line 350 feet northwest of West Belmont Avenue, as measured along

North Clark Street and perpendicular thereto; North Clark Street; and a line 375 feet northwest of

Belmont Avenue, as measured along North Clark Street and perpendicular thereto;

To those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.


