ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-H in the area bounded by

West Henderson Street; a line 125 feet East of and parallel to North Ravenswood Avenue; the alley next South of and parallel to West Henderson Street; and a line 100 feet East of and parallel to North Ravenswood Avenue

to those of a RT3.5 Residential Two-Flat; Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


