SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited manufacturing/Business Park District symbols and indications as shown on Map No. 26 -A in the area bounded by:

A line 72.50 feet north of and parallel to east 108<sup>th</sup> street, the alley next east of and parallel to South Burley Avenue; East 108<sup>th</sup> Street; And South Burley Avenue

to those of a C1-2 Neighborhood Commercial District.
