#### RESOLUTION

#### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHICAGO,

**SECTION 1.** Rule 14 of the Rules of Order and Procedure of the City Council, City of Chicago, for the 2019 – 2023 term is hereby amended by inserting the language underscored, as follows:

RULE 14. Every member who shall be present when a question is stated from the Chair shall vote thereon electronically or, at the discretion of the Chair, verbally, unless excused by the Council.

A City Council member with a conflict of interest that requires recusal, including pursuant to Section 2-156-030 or Section 2-156-080(b)(1) or (b)(2) of the Municipal Code, may not, in a meeting of either the City Council or one of its committees, preside over any hearings or participate in any debate, discussion or vote, including conversation with other members of the City Council, regarding the matter associated with the recusal. The basis for any recusal must be publicly disclosed in detail at the time of a vote. Any member seeking to recuse themselves from any matter other than as required by Sections 2-156-030 or Section 2-156-080(b)(1) or (b)(2) of the Municipal Code of Chicago shall disclose the recusal on the record of the meeting and abstain from participating in any discussion concerning or voting on the matter, but may be counted present for purposes of a quorum. The Clerk shall create a record of all recusals in each meeting and send it to the Board of Ethics, which shall post it on its website as soon as practicable.
