BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is

hereby amended by changing all of the RM5 Residential Multi-Unit District, B3-3 Community

Shopping District and C2-3 Motor Vehicle-Related Commercial District symbols and indications

as shown on Map No. 12-E in the area bounded by:

A line 249 feet north of and parallel to the north line of East 51st Street; South Prairie Avenue; East 51st Street; a line 93.30 feet west of and parallel to the west line of South Prairie Avenue; a line 99 feet north of and parallel to the north line of East 51st Street; the public alley next west of and parallel to South Prairie Avenue,

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 23, 2022, the undersigned will file an application for a change in zoning from RM5 Residential Multi-Unit District, B3-3 Community Shopping District and C2-3 Motor Vehicle-Related Commercial District to B2-3 Neighborhood Mixed-Use District, on behalf of 5050 Prairie LLC, an Illinois limited liability company, for the property located at 5036-5058 South Prairie; 224-232 E. 51st Street, Chicago, Illinois and described as follows:

A line 249 feet north of and parallel to the north line of East 51st Street; South Prairie Avenue; East 51st Street; a line 93.30 feet west of and parallel to the west line of South Prairie Avenue; a line 99 feet north of and parallel to the north line of East 51st Street; the public alley next west of and parallel to South Prairie Avenue.

The property is currently vacant. The purpose of the zoning amendment is to permit the construction of a new 4-story, 49-unit building. There will be not less than 27 parking spaces.
