



In accordance with the requirements for amendments to the Chicago Zoning Ordinance, Section 17-13-0107, please be informed that on or about May 23, 2022, the undersigned will file an application on behalf of Pristine, LLC, for a change in zoning from Residential-Business Planned Development 186, as amended to Dx-16, Downtown Mixed-Use District for the property located at 151-183 N. Michigan Avenue.

The applicant seeks an amendment to the zoning ordinance in order to make it eligible for an administrative adjustment under Section 17-4-1008 or the Chicago Zoning Ordinance that will allow an increase in the floor area ratio by not more than 5% of the FAR existing in 2016. This application will not permit any increase in FAR or residential density. The property is currently improved with an existing 40-story mixed-use building with 563 dwelling units, 122 parking spaces and 88,685 square feet of office space.

The applicant of the subject property is Pristine LLC, which is located at 14 Main Street, Park Ridge, Illinois 60068. The owners of the subject property are Pristine LLC (as to 151 N.
