#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No.3-J in the area bounded by

West Division Street; the southwest right-of-way line of the Chicago Milwaukee and St. Paul Railroad; a line 524.60 feet southwest of the intersection of North Central Park Avenue and West Grand Avenue as measured along the northerly right-of-way line of West Grand Avenue and perpendicular thereto; the centerline of the now vacated alley next north of West Grand Avenue; a line 475 feet southwest of the intersection of North Central Park Avenue and West Grand Avenue as measured along the northerly right-of-way line of West Grand Avenue and perpendicular thereto; West Grand Avenue; and North Central Park Avenue,

to those of a B3-2 Community Shopping District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


