BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indications as shown on Map No. 18-E in an area bound by:

A line 29.14 feet north of and parallel to East 77th Street; South Langley Avenue; East 77th Street; the alley next west of and parallel to South Langley Avenue.

To those of a RM – 4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.


