BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the B3-2 Community Shopping District symbols and indications as shown on Map No. 4-H in the area bounded by

The public alley next north of and parallel to West 18th Street; a line 240.50 feet east of and parallel to South Wolcott Avenue; West 18th Street; and a line 216.50 feet west of and parallel to South Wolcott Avenue

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.






PROPOSED THIRD FLOOR PLAN #1



In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about July 20, 2022, the undersigned, will file an application on behalf of the applicant Agar Holdings, LLC – 1836 W. 18th Series for a change in zoning for the property located at 1836 W. 18th Street from B3-2 Community Shopping District to a B2-3 Neighborhood Mixed-Use District.

The owner of the subject property and the applicant of the Zoning Amendment is Agar Holdings LLC – 1836 W. 18th Street Series located at 4044 N. Lincoln Avenue #350, Chicago, Illinois 60618.

The Applicant seeks a zoning map amendment to add a single new dwelling unit to an existing six dwelling unit residential building with a fourth-floor addition that will be setback from the existing building to preserve the existing building and its façade.
