ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 2-G in the area bounded by

The public alley next north of and parallel to West Flournoy Street; A line 247.28 east of and parallel to South Laflin Street; West Flournoy Street; and a line 271.28 east of and parallel to South Laflin Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to a B2-3 Neighborhood Mixed-Use District.


The purpose of the rezoning is to adaptively reuse a 3.5-story residential building. The Applicant proposes to establish 2 existing, nonconforming dwelling units at the garden level of the existing building containing 6 other dwelling units. No changes are proposed to the existing structure of the building, which will remain the same size. The existing height of the building at 35.83' will remain. The property is a transit served location and is within 1,320 feet of the Ashland CTA Bus Route #9. Zero parking spaces will be added for the two units.*



Flournoy Street from a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to a B2-3 Neighborhood Mixed-Use District.
