#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** That Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1-I in the area bounded by:

West Superior Street; a line 285.70 feet west of and parallel to North Western Avenue; the public alley next south of and parallel to West Superior Street; and a line 309.70 feet west of and parallel to North Western Avenue

to those of a RM-4.5 Residential Multi-Unit District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, please be advised that on or about July 20, 2022, the undersigned, Matthew Allee, will file an application, on behalf of the applicant Jennifer Cushman, for a change in zoning from an RS-3 Residential Single-Unit (Detached House) District to an RM-4.5 Residential Multi-Unit District for the property located at 2429 West Superior Street, Chicago, Illinois.
