Amendment of Municipal Code Chapter 2-84 by adding new Section 2-84-520 regarding reimbursement of basic recruit training paid and provided for by Department of Police

**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Chapter 2-84 of the Municipal Code of Chicago is hereby amended by adding a new Section 2-84-520, as follows:

**2-84-520 Training – Reimbursement.**

Any police officer who completes basic recruit training paid for or provided by the Department of Police and who leaves the Department for another police department within 5 years of graduating the Department's Recruit Academy must reimburse the City for the costs of their training.

**SECTION 2.** The Superintendent of Police shall create a process to allow for the Department of Police to accept transfers of police officers who have been trained by another jurisdiction. The transfer officer may be allowed to complete a modified training program.

**SECTION 3.** This ordinance shall take effect 10 days after passage and publication.






