

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17, of the Municipal Code of Chicago - the Chicago Zoning

Ordinance, be amended by changing all of the RS-3 Residential Single-Unit (Detached

House) District symbols and indications, as shown on Map No. 3-G, in the area bounded

by

The alley next north of and parallel to West Cortez Street; a line 320.50 feet west of the intersection of North Milwaukee Avenue and West Cortez Street as measured along the north right-of-way line of West Cortez Street and perpendicular thereto; West Cortez Street; and a line 344.50 feet west of the intersection of North Milwaukee Avenue and West Cortez Street as measured along the north right-of-way line of West Cortez Street and perpendicular thereto,

to those of an RM-4.5 Residential Multi-Unit District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


