#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago - the Chicago Zoning Ordinance, is hereby amended by changing all of the *RS-3 Single-Unit (Detached House)*District symbols and indications, as shown on Map No. 3-G, in the area bounded by

the alley next north of and parallel to West Cortez Street; a line 340.50 feet east of and parallel to North Ashland Avenue; West Cortez Street; a line 315.50 feet east of and parallel to North Ashland Avenue,


to those of an RM-4.5 Residential Multi-Unit District.


