SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current Plaimed Development No. 997 symbols and indications as shown on Map No. 1-F in the area bounded by:

the alley next north of West Randolph Street; a line 162.33 feet east of North Wells Street; West Randolph Street and a line 80.00 feet east of North Wells Street

to those of Planned Development No. 997, as amended, which is hereby established in the area described above and subject to such use and bulk regulations set forth in the Plan of Development attached hereto and to no others.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

PLANNED DEVELOPMENT NO. 997, AS AMENDED

<u>Plan of Development Statements</u>

- 1. The area delineated herein as Planned Development No. **997**, as amended (the "Planned Development") consists of a net site area of approximately 14,708.5 square feet (.34 acres) of property, which is depicted on the attached Planned Development Boundary and Property Line (the "Property"), and is controlled for purposes of this Planned Development by Clovis Investments, LLC (the "Applicant").
- 2. All applicable official reviews, approvals or permits are required to be obtained by the applicant or its successors, assignees or grantees. Any dedication or vacation of streets, alleys or easements or any adjustment of the right-of-way shall require a separate submittal on behalf of the Applicant or its successors, assignees or grantees and approval by the City Council.
- 3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the applicant's successors and assigns and, if different than the applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined section 17-8-0400 of the Chicago Zoning Ordinance ("Zoning Ordinance").
- 4. This Plan of Development consists of Fourteen (14) Statements; a Bulk Regulations and Data Table; an Existing Zoning Map; a Plarmed Development Boundary and Property Line; a Green Roof Plan; a Site Plan and Elevations prepared by Smdio D Architecture, LLC dated December 1, 2010. Full-size sets of the Site Plans and Elevations are on file with the Department of Planning and Development. These and no other zoning controls shall apply to the Property. This Plan of Development conforms with the intent and purpose of the Chicago Zoning Ordinance (Title 17 of the Municipal Code in Chicago) and all requirements thereof, and satisfies the established criteria for approval as a Planned Development. In any instance where a provision of the Planned Development conflicts with the Chicago Building Code, the Building Code shall control.
- 5. The property within the Planned Development is indicated on the Planned Development Boundary and Property Line. Subject to the Bulk Regulations and Data Table, the following uses are permitted on the Property:

Hotel, residential dwellings, senior housing, commercial, retail and nonaccessory parking (including the existing interim surface parking lot) and accessory uses including loading and parking.

6. On-Premise signs and temporary signs such as construction and marketing signs shall be permitted within the Planned Development subject to the review and approval of the Department of Zoning and Planning (DZP). Off-Premise signs are prohibited within the boundary of the Planned Development.

- 7. Off-street parking shall be provided in compliance with this Planned Development subject to review of the Department of Transportation. Parking for the uses on the Property may be provided off-site subject to the approval of the Department of Zoning and Planning. Any service drives or other ingress or egress shall be adequately designed and paved in accordance with the Municipal Code of Chicago, to provide ingress and egress for motor vehicles, including emergency vehicles. There shall be no parking within such paved areas. Ingress and egress shall be subject to the review and approval of the Department of Transportation.
- 8. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration.
- 9. The improvements depicted on the Site Plans and Elevations including the landscaping along adjacent rights-of-way and all entrances and exits to and from the parking and loading areas shall be designed, constructed and maintained in substantial conformance with the Site Plans and Elevations.
- 10. The terms and conditions of development under this the Plarmed Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Commissioner of the Department of Zoning and Planning upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
- 11. The applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. All developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Department of Zoning and Planning. To that end, the Applicant shall provide a vegetated ("green") roof on 50% percent of the net roof area of the building consisting of approximately 14,000 square feet to be redeveloped pursuant to the this Planned Development.
- 12. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project buildings in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities (MOPD) to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.

- 13. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioner of the Department of Streets and Sanitation, the Commissioner of the Environment and the Commissioner of Buildings under Section 13-32-125 of the Municipal Code of Chicago or any other provision of that Code.
- 14. Unless substantial construction of the improvements, other than the existing surface parking lot, contemplated by this Planned Development has commenced within six (6) years of the effective date hereof and unless completion of those improvements is thereafter diligently pursued, then this Planned Development shall expire and the zoning of the Property shall automatically revert to a DX-16 Downtown Mixed-Use District classification applicable to the Property prior to adoption of this Planned Development. The six-year period may be extended for one (1) additional year if, before expiration, the Commissioner of the Department of Planning and Development determines that good cause for such an extension is shown.


180 W. Randolph St. Mixed Use Building






PROPOSED EAST SIDE ELEVATION
