#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:





#### **Obituary**

Our own Chicago resident Richard Techman, passed away on October 15, 2022. He was honored and celebrated by many friends and family as being a dedicated husband and a hard worker.

Richard was a lifelong resident of the 23rd Ward, was a parishioner of St. Daniel the Prophet Church. He graduated from John F, Kennedy High School in 1975. He would go on to attend Richard d. Daley College graduating in 1989 then attending Columbia College Chicago and graduating in 1992.

Richard Techman had also worked diligently for more than four decades for his local community. He joined the Garfield Ridge Civic League in 1984 and acted as its president from 2005 to 2015. He has remained a member since, and has helped in events ranging from fundraising to solving local community problems and Beat 811 Garfield Ridge Neighborhood Watch recently commented that he was their Traffic Control Safety at all their events. Mr. Techman was always one of the first ones to sign up to volunteer and help at all of Alderman Tabares' (23rd Ward events)

He is survived by his loving wife Michelle Techman of 14 years.

Richard's life would seem too short to many but he was loved by and will be missed by many. Although he is no longer with us, we will carry him in our hearts.
