## **ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

South Wallace Street; West 30<sup>th</sup> Street; the public alley next and parallel to South Wallace Street and a line 50 feet north and parallel to West 30<sup>th</sup> Street.
