Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MR. JUAN SALGADO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Fire Escape projecting over the public right-of-way adjacent to its premises known as 2348 S. Blue Island Ave.. Existing fire escape along South Blue Island Avenue measure seventeen (17) feet six (6) inches in length, four (4) feet four (4) inches in width and fifteen (15) feet above the sidewalk.

The location of said privilege shall be as shown on prints hereto attached, which by reference are hereby incorporated and made a part of this ordinance.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development)

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-075 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1090098 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period offive (5) years from and after 01/12/2010.
