ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map Number 6-G in the area bounded by:

A line 605.5 feet south of and parallel to West 29th Street; South Halsted Street; a line 101.9 feet north of and parallel to West 31st Street; and a line beginning at a point 47.44 feet west of South Halsted Street and 101.9 feet north of West 31st Street and continuing northwesterly to a point 361.67 feet west of South Halsted Street and 605.5 feet south of West 29th Street

to those of a B3-2 Community Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.





In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about December 14, 2022, the undersigned will file an application for a change in zoning from B1-2 Neighborhood Shopping District to B3-2 Community Shopping District on behalf of the applicant, Circuit Associates, LLC, for the property located at 3000-3048 S. Halsted Street.

The purpose of the proposed change in zoning is to allow for replacement of the existing nonconforming shopping center sign at the perimeter of the subject property (which is 25' 9" in height and 14' 4" in width) with a new, smaller sign (24' 0" in height and 13' 0" in width). Total sign area would be reduced from 1,523 square feet to 1,419 square feet. No other changes to the shopping center or to other existing signage are contemplated at this time.
