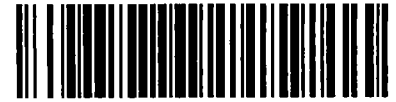

WHEREAS, Scott was born and raised in Chicago and attended Portage Park Elementary School and Lane Tech College Prep where he earned high honors; and


WHEREAS, Scott served 5 years with the Cook County Sheriff's Office as a guard in Cook County Jail; and
