WHEREAS, A loving aunt, cherished godmother, and dear friend of many, Ms. Devaney was known for her dedication, love, generosity and care for her family and friends; and

WHEREAS, Although Ms. Devaney will be dearly missed, the impact of her kindness and many good deeds will continue to inspire others, and her memory will live on in the hearts of those who were privileged to know her; and

WHEREAS, A truly exemplary human being, Ms. Devaney will always be remembered for her selfless dedication to public service, her many contributions to the City of Chicago, and for her modesty, strength of character, and faith; and
