BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-L in the area bounded by:

The alley next north of and parallel to West Newport Avenue; a line 61.18 feet east of and parallel to North Lockwood Avenue; West Newport Avenue; and North Lockwood Avenue.

To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 15, 2023, the undersigned will file an Application for a change in zoning from an RS3 Residential Single-Unit (Detached House) District to an RT4 Residential Two-Flat, Townhouse and Multi-Unit District on behalf of the Applicant, MF INVESTMENT LLC, for the property located at 5254-56 West Newport Avenue, Chicago IL 60641.

The subject property is currently improved with a multi-unit residential building with 7 dwelling units. The Applicant proposes to demolish the existing building, divide this property into 2 zoning lots (each lot measuring 30.59' x 125.34') and redevelop each new lot with a new 3-story residential building with 3 dwelling units.
