#22/18 INTRO DATE MARCH 15, 2023

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the Planned Development No. 1277 symbols and indications as shown on Map Number 1-G in the area bounded by:

West Fulton Market; North Halsted Street; a line 84 feet south of and parallel to West Fulton Market; a line 126.04 feet west of and parallel to North Halsted Street

to those of DX-7, Downtown Mixed-Use District.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and due publication.






