ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols as shown on Map No. 15-G in the area bounded by:

West Devon Avenue; a line 375 feet west of and parallel to North Greenview Avenue; the alley next south of and parallel to West Devon Avenue; and a line 406.25 feet west of and parallel to North Greenview Avenue.

To those of a B2-3 Neighborhood Mixed-Use District

















02 SECOND FLOOR PLAN






