

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing the RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District symbol and indication as shown on Map No. 16-D in the area bounded by

South Maryland Avenue; A line 273.18 feet south of and parallel to East Marquette Road; the alley next east of and parallel to South Maryland Avenue; and a line 298.18 feet south of and parallel to East Marquette Road.
