ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M3-3 Heavy Industry District symbols and indications as shown on Map No. 5-H in the area bounded by

West Fullerton Avenue; a line 100 feet east of and parallel to North Seeley Avenue; the alley next south of and parallel to West Fullerton Avenue; and North Seeley Avenue,

to those of a C2-3 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

Project Narrative And Plans Type 1 Rezoning Map Amendment Zoning District from M3-3 to C2-3 2023 W Fullerton Ave, Chicago, IL 60647

The project

To change the zoning district from M3-3 to C2-3, seeking a Type 1 zoning map amendment for the remodeling of the existing one-story brick building to contain:

 Commercial space on the ground floor to establish a Cannabis Business Establishment use

The site

The 12,500 square foot site (a parcel approximately 100 feet (frontage) x 125 feet) is located at 2023 W Fullerton Ave, Chicago, IL 60647. The subject property is improved with a one-story building containing approximately 9,679 square feet of floor area plus approximately 2,821 square feet for parking. The land uses in the immediate vicinity of the subject property consist of a residential multi-unit across the public alley to the South; a residential multi-unit across Seeley Avenue to the West; a Waterway-Business Planned Development (tennis club) across Fullerton Avenue to the North; and a commercial brick building immediately to the East.
