#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 3-I

West Augusta Blvd.; a line 100 feet West of and parallel to North Rockwell Street; the public alley next South of and parallel to West Augusta Blvd.; and a line 131.50 feet West of and parallel to North Rockwell Street.

To those of an RM-5 Residential Multi-Unit District.

SECTION 2. This Ordinance takes effect after its passage and due publication.










