parallel to North Oakley Avenue; a line 67.50 feet north of and parallel to West Ainslie Street; a line 62.00

feet west of and parallel to North Oakley Avenue; West Ainslie Street; and a line 140.29 feet west of and

parallel to North Oakley Avenue.

To those of a RM-5 Residential Multi-Unit District

SECTION 2. This ordinance takes effect after its passage and due publication.




# Narrative and Plans Type-1 Zoning Map Amendment For 2306-12 W Ainslie St


