BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 7-H in the area bounded by:

A line 145.45 feet north of and parallel to West Oakdale Avenue; North Leavitt Street; a line 70.45 feet north of and parallel to West Oakdale Avenue; and the alley next west of and parallel to North Leavitt Street.

to those of a C2-2 Motor Vehicle-Related Commercial District.

SECTION 2. This Ordinance be in force and effect from and after its passage and due publication.






