ZONING ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 3-I in the area bounded by:

West Augusta Blvd.; a line 134' east of and parallel to North Washtenaw Avenue; the public alley next south of and parallel to West Augusta Blvd.; a line 100 feet east of and parallel to North Washtenaw Avenue

To those of a RM-5 Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.




